Licenses the publisher to publish and reuse the manuscript. To be used by authors who cannot assign copyright because they are **public servants in a Commonwealth country** (such as Canada, UK, Australia).

Publication Agreement (US Official)

Declares that the author is an **official of the US government**, in which case there is no US copyright on the manuscript.
